When the parade starts at 9:00 a.m., all vendors must move behind the crowds, leaving the parade route clear – regardless of whether the parade has reached that location. <b>The permit issued by The Days of '47, Inc. upon acceptance of this Application and payment of the appropriate fee must be posted and visible and the issued badge must be worn by each individual participating.</b> The parade route starts at South Temple and State Street and proceeds east to 200 East, turns south to 900 South then east to Liberty Park.  If you are selling or distributing from a cart of any type, each cart must have a separate permit.  Horns may not be sold due to the danger of spooking horses. You may be required to relocate to accommodate parade announcers or for other reasons, as directed by The Days of '47 Parade Committee or law enforcement personnel.
